Letter from the president

A young man was newly elected to the congregation's Board of Directors. 

We discover that, in death, Lincoln becomes an Americanization vehicle that helps Jews demonstrate that American values

This study session will constitute a rare opportunity to explore this interesting topic with Dr. Zola, who is now serving on the Academic Advisory Council of the congressionally recognized Abraham Lincoln Bicentennial Commission in Washington, D.C.
